2. To pay interest charges on any delinquent amount up to the maximum rate prescribed by North Carolina law.
3. To pay all reasonable charges for collection, including reasonable attorney fees and court costs, if the account is placed with an attorney or collection agency.
4. That MWD Inc.'s standard terms and conditions set forth on its sales order shall govern all sales to the undersigned.
5. In the event legal action is commenced to enforce any of the terms of purchase or obligations created hereby or under any transaction between the undersigned and MWD Inc., hereafter, the legal action will be commenced in, and the proper place of trial therefore shall be a court of competent jurisdiction in the county in which the distributing warehouse is located.
6. I/we hereby authorize MWD Inc. to investigate references listed, banks and credit reporting agencies pertaining to my/our credit and financial responsibility.

Disputes: In the event the buyer has a dispute with an invoice or invoice amount, buyer must notify MWD Inc., in writing within (10) days of receipt of invoice.
